IN PARTNERSHIP WITH LOCAL VOLUNTEER MEDICAL AND DENTAL PROVIDERS, WE PROVIDED 692 APPOINTMENTS TO 258 UNIQUE PATIENTS, INCLUDING 149 MEDICAL VISITS, 311 DENTAL APPOINTMENTS, 37 COUNSELING VISITS, AND 637 LAB TESTS. THE COVID PANDEMIC HAD A CONSIDERABLE NEGATIVE IMPACT ON OUR ABILITY TO PROVIDE SERVICES DURING THIS PERIOD REQUIRING LONGER WAIT TIMES AND PROTOCOLS FOR CLEANING. RESERVE FUNDS ARE BEING HELD PENDING A FULL-TIME DENTIST, REGISTERED DENTAL HYGIENIST, AND REGISTERED DENTAL ASSISTANT.
